Why Europe Intervenes in Africa Jun 22 2022 Why Europe Intervenes in Africa analyses the underlying causes of all European decisions for and against military interventions in conflicts in African states since the late 1980s. It focuses on the main European actors who have deployed troops in Africa: France, the United Kingdom and the European Union. When conflict occurs in Africa, the response of European actors is generally inaction. This can be explained in several ways: the absence of strategic and economic interests, the unwillingness of European leaders to become involved in conflicts in former colonies of other European states, and sometimes the Eurocentric assumption that conflict in Africa is a normal event which does not require intervention. When European actors do decide to intervene, it is primarily for motives of security and prestige, and not primarily for economic or humanitarian reasons. The weight of past relations with Africa can also be a driver for European military intervention, but the impact of that past is changing. This book offers a theory of European intervention based mainly on realist and post-colonial approaches. It refutes the assumptions of liberals

and constructivists who posit that states and organisations intervene primarily in order to respect the principle of the 'responsibility to protect'.

Operation Goodtime and the Battle of the Treasury Islands, 1943

Nov 27 2022 A force of New Zealanders and Americans invaded the Treasury Islands in the South Pacific on October 27, 1943, retaking them from their Japanese occupiers. Codenamed Operation Goodtime, the action marked the first time New Zealand forces took part in an opposed landing since Gallipoli in 1915. In an unusual allocation of troops in the American-dominated theater, New Zealand provided the fighting men and America the air, naval, and logistical support. Confronting extreme risks against a determined Japanese foe, the Allies nevertheless succeeded with relatively few casualties. Because of the need for operational security, Operation Goodtime received little publicity and has been relegated to a footnote in the history of the war in the Pacific. This is the first complete account of the Allied seizure of the Treasury Islands.

Multiples Organversagen May 21 2022 Bereits seit Jahrzehnten ist in den Industrieländern das multiple Organversagen die dritthäufigste Todesursache, - nach den Herz-Kreislauferkrankungen und den vielfältigen Krebserkrankungen. In Deutschland sind dem multiplen Organversagen mehr als 70.000 Todesopfer/Jahr zuzuschreiben. Die häufigsten Ursachen sind Sepsis, Polytraumata, kritisch verlaufende Virusinfektionen wie auch toxische Einwirkungen. Ausgangspunkt ist eine Zellschädigung gleich in welchem Organ, welche zur lokalen Aktivierung der Abwehr und Reparatursysteme des Körpers führt. Hierzu gehören das Kinin-, das Komplement-, das Gerinnungs- und das Fibrinolysesystem wie auch das unspezifische und spezifische Entzündungs- und Immunsystem. Diese aktivierte Systeme dienen einerseits der Begrenzung und Ausheilung der ursprünglichen Schädigung, können bei persistierendem oder sich verstärkendem Schaden aber auch in eine sich

selbstverstärkende Aktivierungsspirale münden, in einen Teufelskreis, welcher im primär betroffenen Organ dessen teilweise oder vollständige Funktionsunfähigkeit bewirkt, bei Versagen der lokalen Regulationsmechanismen die Abwehrsysteme auch in anderen Organen aktiviert und dort zu weiteren Zellschädigungen und Funktionsbeeinträchtigungen führt, in den Blutkapillaren aller betroffenen Organe in eine verstärkte Gerinnung bei mangelnder oder fehlender Fibrinolyse mündet und letztlich im multiplen Organversagen als katastrophale Folge endet. Zu verhindern sind die schwerwiegenden Folgen des multiplen Organversagens nur durch eine frühe Diagnostik von aktivierten Faktoren der Abwehrsysteme, durch eine Kompensation der durch die Abwehrsysteme bedingten Schäden und durch eine Stärkung derjenigen Faktoren, welche die Gerinnung hemmen und die Fibrinolyse fördern. capital is the subject of this study of Exeter during the Elizabethan and early Stuart ages. The author offers new insight into the way the English middle-class lived and the way in which Tudor policy achieved its aims in the provinces. During this period, Exeter was characterized by its self-sufficiency and by an oligarchical control over every aspect of its civic life. Wallace MacCaffrey describes a semi-autonomous world in itself, in which a small interlocked group of merchant families, related by marriage, kept tight control over the economy, politics, religion, education and social activities. Taking the inclinations and actions of the local figures as his points of departure, the author discusses such great issues of the age as the Reformation, the war with Spain, and the monarchy, and examines how often they were pushed aside or subordinated to local affairs. Although the local citizen body had no part in national policy making, it was called upon to participate in carrying out the directives which came from London; it did carry out these policies, sometimes successfully, sometimes unsuccessfully. In writing this detailed study, MacCaffrey has drawn on hitherto unused files from the records of the city.
